## Service Officer

### Dependents and Survivors Benefits

#### Death Gratuity Payment

Military services provide payment, called a death gratuity, in the amount of \$100,000 to the next of kin of servicemembers who die while on active duty (including those who die within 120 days of separation) as a result of service-connected injury or illness.

If there is no surviving spouse or child, then parents or siblings designated as next of kin by the service member may be provided the payment. The payment is made by the last military command of the deceased. If the beneficiary is not paid automatically, application may be made to the military service concerned.

#### Dependency and Indemnity Compensation

**Eligibility:** For a survivor to be eligible for Dependency and Indemnity Compensation (DIC), the veteran's death must have resulted from one of the following causes:

1. *A disease or injury incurred or aggravated in the line of duty while on active duty or active duty for training.*
2. *An injury, heart attack, cardiac arrest, or stroke incurred or aggravated in the line of duty while on inactive duty for training. A service-connected disability or a condition directly related to a service-connected disability.*

DIC also may be paid to certain survivors of veterans who were totally disabled from service-connected conditions at the time of death, even though their service-connected disabilities did not cause their deaths. The survivor qualifies if the veteran was:

1. *Continuously rated totally disabled for a period of 10 years immediately preceding death; or*
2. *Continuously rated totally disabled from the date of military discharge and for at least 5 years immediately preceding death; or A former POW who died after Sept. 30, 1999, and who was continuously rated totally disabled for a period of at least one year immediately preceding death.*

The above information was taken from the current Federal Benefits for Veterans and Dependents Guide and is subject to change with legislation. As with ANY benefits from the Veterans' Benefits Administration, it is best to obtain an appointment with one of our County Veteran Services Officers for assistance in determining eligibility and with filing a claim.
