## Service Officer

### The 1973 National Personnel Records Center Fire:

Over the past several years I have talked to a good many veterans about obtaining copies of their Military Service and Medical Records. Often I hear them say "mine were destroyed in the fire". After discussing their branch of service and the time frame they were on Active Duty, they were surprised to learn that their records were not part of those destroyed as they had thought. The information below was extracted directly from the National Archives and Records Administration, Veterans' Records Section ([www.archives.gov/veterans](http://www.archives.gov/veterans)) and is provided here for informational purposes.

On July 12, 1973, a disastrous fire at the National Personnel Records Center (NPRC) destroyed approximately 16 to 18 million Official Military Personnel Files (OMPF). The records affected were:

**Army:** Personnel discharged November 1, 1912 to January 1, 1960. Estimated loss of 80%.

**Air Force:** Personnel discharged September 25, 1947 to January 1, 1964 after last name Hubbard. Estimated loss of 75%

No duplicate copies of these records were ever maintained, nor were microfilm copies produced. Neither were any indexes created prior to the fire. In addition, millions of documents had been lent to the Department of Veteran Affairs before the fire occurred. Therefore, a complete listing of the records that were lost is not available. However, in the years following the fire, the NPRC collected numerous series of records, referred to as Auxiliary Records that are used to reconstruct basic service information.
