Service Officer Report

Last month I received multiple requests concerning Power of Attorney (POA). As a Service Officer at Post 318, I am not accredited to become a veteran's representative. Additionally, I am not permitted to assign the American Legion as a representative. I reached out to the St. Lucie Veterans Services office for help with understanding the POA process. Wayne Teegardin, Veteran Services Manager provided the following brief:

VA Form 21-22 – Appointing a Power of Attorney (POA) Representative. A POA Representative must obtain recognition (accreditation) from the VA's Office of General Counsel in order to represent claimants. Generally, a POA representative is selected by the Veteran to represent them in matters that may come before the VA for determination, such as a claim decision or appeal. The POA representative advises the Veteran prior to and during any appeal hearings or administrative matters before a VA Judge. VA Power of Attorney –VS- General Power of Attorney Under State Law: The execution by a Veteran of a power of attorney under State law has no effect for the purposes of prosecuting a VA claim. In order to be recognized by Department of Veterans Affairs (VA), a claimant's POA representative must be appointed and accredited, as previously stated, by the VA's Office of General Counsel. A POA representative for VA purposes has limited power specific to representing Veterans before the VA. A representative is authorized to prepare, present, and prosecute a claimant's claim and has the authority to:

1. Review the claimant's records
2. Present evidence on behalf of the claimant
3. Sign an informal claim, a notice of disagreement (NOD), or a substantive appeal on behalf of the claimant, and
4. Withdraw an appeal.


